Environmental improvements:

 Green Spaces - A sack of bulbs for planting has been shared between the Cragg Vale schools, with a few remaining to be planted in local open spaces. Plans are in hand for 'weed-killing' (HimalayanBalsam) next May and 'Feed the Birds' suggestions have been put forward

- Park Project At last there will soon be visible proof of all the time and efforts spent in the planning stages of the 1st phase of improvements A Dart Activity Centre is the piece of equipment chosen and, weather permitting, installation is set to begin in January. Meanwhile the possibilities and practicalities of a composting toilet (a top priority from one earlier consultation) are being looked into.
- Cragg Vale Spa Leeds University students are to make a start at the Spa in the new year, undertaking a site investigation, clearance around the Spa and mapping of the area. A water sampling campaign is anticipated, with samples taken from the Spa from the surrounding springs, in order to establish if the chemical properties of the Spa water are in any way different to other spring waters and to identify if any of these chemicals are associated with the traditional restorative. An historical investigation of the Spa is also planned, to try trace its origins, pinpoint the era when it was at the height of popularity, determine the architectural form of the Spa at this time and establish the boundaries of its likely use. - Cragg Vale Carbon Neutral Group has a vision to 'Make Cragg Vale Carbon Neutral' via supporting people in their own usage, to harness water power in the valley, and to have a 'flagship project'. The group is planning to have a big launch meeting in March. (contact Maggie at maggie@maggiesmallwood.com).

Following the 178 to 1 vote of support at the recent public meeting, Kerbside is continuing its campaign for recycling collection in Calderdale – which, as a social enterprise scheme, also assists disadvantaged unemployed people to progress into work.
